Unidentifiable and Untraceable depositors in claims prepared by Liquidators

डीओसीजीसी अधिनियम, 1961 की धारा 17 और 18 में निहित प्रावधानों के अनुसार निक्षेप बीमा और प्रत्यय गारंटी निगम (डीओसीजीसी) परिसमापक द्वारा तैयार किए गए दावों का निपटान करता है। परिसमापक द्वारा पहचाने न गए/ पता न लगाए जा सके बीमाकृत जमाकर्ताओं का दावा डीआईसीजीसी द्वारा प्रदान किया जाता है। ऐसे जमाकर्ताओं से संपर्क करने के लिए (देरी का कारण बताते हुए) और 31 मई, 2019 तक डीआईसीजीसी के मानकों के अनुसार दावे, यदि कोई हो, तो प्रस्तुत करने के, सहकारी समितियों के रजिस्ट्रार और बैंकों (जनवरी 1, 2008 और दिसंबर 31, 2019 के बीच परिसमापित) के परिसमापकों को निर्देश जारी किए गए हैं। डीआईसीजीसी की वेबसाइट www.dicgc.org.in पर बैंकों की सूची उपलब्ध है।

Deposit Insurance and Credit Guarantee Corporation (DICGC) settles claims prepared by liquidators in terms of provisions contained in Sections 17 and 18 of DICGC Act, 1961. The claims of insured depositors who are unidentifiable/untraceable by liquidators is provided for by DICGC. Instructions have been issued to Registrar of Cooperative Societies and liquidators of banks (**of banks liquidated between January 1, 2008 to December 31, 2008**) to contact such depositors (stating reasons for delay) and submit the claims, if any, to DICGC till May 31, 2019 as per DICGC norms.
