Depositors, whose alternate bank accounts are linked to their Aadhaar card and desirous of receiving their deposit amounts into their Aadhaar linked bank accounts may opt to give a mandate for receiving the payment through Aadhaar enabled payment system. Depositors, who have not yet submitted their claims should contact the banks and submit their claims and documents not later than **Friday**, **December 10, 2021**. The deposit amount, up to a maximum of Rs.5 lakh, will be credited into the alternate bank accounts, as indicated, by Friday, December 31, 2021.
